2. Distinctive features of the programme encompassing the Student Experience

- This is the only FdSc Counselling Psychology with Criminology in the Southwest, which also has the bonus of including counselling skills training.
- Taught by professional counsellors with additional teaching qualifications and experience of working in the field of counselling and the criminal justice system.
- The FdSc contains the required psychological content, for those that wish to, to apply to continue study to a BSc Psychology. The British Psychology Society publish the subject specialist areas required within the field of psychology to comply to their standards of a psychology degree. These are Cognitive Psychology, Social Psychology, Developmental Psychology, Individual Differences, Research Methods and Conceptual/Historical issues. All these key areas are included in the FdSc.
- The FdSc contains a counselling skills module and a counselling theory model. These are deemed commensurate with the Level 2 Counselling Skill qualification. Successful completion of both, with 80% attendance will lead to a Cornwall Counselling Institute

proficiency certificate at no extra cost. A Counselling Skills Certification is relevant to range of helping professions across the mental health sector, education, social services and supportive roles with a customer facing component.

- The Cornwall Counselling Institutes' (CCI) Counselling Skills Certification will be considered commensurate to the Level 2 Counselling Skills qualification (which forms part of the mandatory admissions criteria for the Level 5 Diploma in Person-Centred Counselling and Therapy). Should students wish to transfer to this programme, they will be able to do so, without completing a further training course.
- This programme explores a range of psychological modules which contribute to our understanding of the causal factors behind criminal behaviour. It also offers opportunities to study the impact of wider environmental issues to explain criminal behaviour and victimology. Central to the programme is a focus on rehabilitation and how to work therapeutically with both offenders and victims of crime. This is useful for students wishing to pursue a career in the helping professions or a career in the social justice professions.
- Both the British Psychological Society and the BACP British Association of Counselling and Psychotherapy Framework for Ethical Practice underpin the programme.

3. Programme Aims

This programme aims:

1. To promote a therapeutic analysis of the process of human dysfunction
2. To offer opportunities to develop an understanding of a range of psychological approaches and theories to explain the development and maintenance of human dysfunction linked to criminal behaviour
3. To explore, from a variety of social and environmental perspectives, the causes behind criminal behaviour, crime prevention, penology, and treatment approaches offered to offenders and victims of crime
4. To enable the development of analytical and independent research skills, through successfully completing a Research Project module. To empower students to confidently assess the next appropriate progression steps, either through academic study, professional training or employment
5. To develop competency in using introductory level counselling skills safely and competently, to complement existing roles or to become an effective helper in a range of employment settings

4. Programme Intended Learning Outcomes (ILO)

By the end of this programme the student will be able to:

4.1 Knowledge and Understanding

On successful completion of the programme graduates will have developed an understanding of:

- a) The theory of personality development and the acquisition and maintenance of psychological dysfunction
- b) A therapeutic approach applied to both victims and the perpetrators of crime
- c) The impact of wider environmental factors on anti-social behaviour

4.2 Cognitive and intellectual skills

On successful completion of the programme graduates will have developed an ability to:

- a) Analyse and critically evaluate psychological theory in relation to understanding mental health issues
- b) Demonstrate the ability to utilise a range of learning resources to inform academic learning and practice
- c) Engage in intellectual debate surrounding the validity of a range of psychological and sociological explanations behind criminal behaviour and recidivism

4.3 Key and transferable skills

On successful completion of the programme graduates will have developed the ability to:

- a) Communicate professionally and clearly in written and oral forms, and through a research project and present work in an appropriate format
- b) Work within the Cornwall Counselling Institute to develop professional boundaries and work within an ethical framework when engaging with introductory counselling skills practice
- c) Relate to others and self with respect, cognitive and emotional empathy and authenticity, assessed through peer and tutor observations of counselling skills practice

4.4 Employment related skills

On successful completion of the programme graduates will have developed

- a) Interpersonal and inter relational listening and communication skills, appropriate to working with clinical and non-clinical populations
- b) An ability to critically analyse research findings
- c) An understanding of the different roles, responsibilities and functions of a range of professionals. These include, but are not limited to working within the fields of mental health and social justice

4.5 Practical Skills

On successful completion of the programme graduates will have developed

- a) An ability to identify, reflect upon and evaluate their use of counselling skills
- b) An ability to engage in collaborative relationships and develop insight into their own values, beliefs, assumptions and judgements
- c) An ability to identify, understand and apply codes of ethical professional practice

6. Progression Route(s) and criteria for final and intermediate awards

Upon successful completion of 240 credits students will be awarded the FdSc Counselling Psychology with Criminology. There is no guaranteed progression route for this programme.

Any student who has completed a TCCG approved programme and then opts to progress to a University of Plymouth validated programme, within Cornwall College will not be able to use those credits achieved on a TCCG programme as part of their overall degree classification. This therefore means that the outcome of the progression route will be based purely on the Level 6 modules.

Further progression opportunities are available at other HEIs and would be subject to their relevant entry requirements.

Entry Criteria (Qualifications)	Details
Capability statement	TCCG is supportive of students with disabilities and adjusting to assist these students through their studies. On notification of any registered disability or need for learning support, Admissions Teams will notify the Programme Manager and Student Services to ensure that applicants are aware of the support available. Student Services will contact applicants about how to apply for support and guide them through the process to ensure that support is in place at the start of the academic year. The Programme Manager will check prior to commencement of the programme and ensure appropriate adjustments are undertaken (if necessary). It should be noted that students will be expected to engage in dyad and triad counselling practice with peers which will be observed and assessed by a tutor. The broad entry requirements enable applicants from a range of backgrounds and disciplines the opportunity to apply.

8. Modes of Delivery and Assessment

Delivery will include lectures, small group work and seminars. Students will also engage in peer dyad and triad practical practice through work related learning and practical classes where they will be given the opportunity to learn from professional counsellors demonstrating counselling skills practice. Students will receive regular tutorials and benefit from guest lecturers and from industry experts, which also provide networking opportunities.

Assessments will be varied and will include academic essays, a research project, individual and small group presentations, professional discussions, reflective journals and observation feedback and assessment forms.

For more detail on these teaching and learning approaches, please see below:

- Lectures: involving the traditional approach where a single member of staff introduces ideas or delivers facts to a group of students through to the adoption of an interactive approach involving a range of media and technologies and taking place virtually as well as in person.
- Seminars: a discussion or classroom session focusing on a particular topic or project.
- Tutorials: a meeting involving one to one or small group supervision, feedback or detailed discussion on a particular topic or project.
- Demonstrations: a session involving the demonstration of a practical skill or technique.
- Practical classes and workshops: a session involving the development and practical application of a particular skill or technique.
- Work related learning: learning that takes place in the classroom; through dyad practice; with peers and the use of guest speakers (where applicable and able).

And in terms of assessment:

- Written assignment; an exercise completed in writing.
- Research Report; an extended piece of written work, often the write up of a final year programme.
- Oral assessment and presentation; a conversation or oral presentation on a given topic, including an individual contribution or a seminar.
- Practical skills assessment; assessment of a student's practical skills or competence.
- Test; students will be given a time limited opportunity under exam conditions to demonstrate knowledge in the classroom, which prepares them for the pressures of potential exam conditions in the future
- Reflective account /log; a written work that enables the students to develop greater ownership in their learning experience.
- Group Work; where students are expected to work in a team situation to develop teamwork skills.
- Peer assessment; students are encouraged to assess the work of their peers to develop judgement skills, critiquing abilities and self –awareness.

However, the programme will not be limited to these approaches, and we reserve the right to develop new approaches that are not listed above.

9. Transparency Statement

The following are an indication of the potential extras that a student will have the option to undertake as part of their studies. The costs associated are an indication and subject to change. These are aimed at enhancing a student's experience whilst on programme but are not elements that are linked with the assessments on the programme:

There may be some additional costs, primarily for optional activities. Some trips may attract a cost of £5-20 to cover admission to venues; this will be a subsidised cost. Additional qualifications may be available at an additional cost to the student, for example the AET, the cost of such qualifications varies but will be communicated to the student in advance.

The FdSc supports work related learning through the counselling skills training, students who complete both the Counselling Skills module and the Contemporary Counselling Paradigms module in Year 1 will be awarded Cornwall Counselling Institute certification at an introductory level of competence in the use of counselling skills. Students will also engage in work related learning in Year 2 through the Therapeutic Approaches to Offender Rehabilitation module, when they practice a range of contemporary therapeutic approaches used with offenders and assess their effectiveness. Due to the subject matter, FdSc students would not ethically be allowed to work with clients in a therapeutic setting, nor with victims and perpetrators of crime, therefore their counselling skills practice will be conducted with peers under observation by a professional counsellor. These skills will be relevant to students wishing to pursue a career in the helping professions or any customer facing roles.
